<p>Immerse yourself in our enchanting woodland of Lees Wood that bursts with nature and wildlife. Explore our Nature Trail created by The Volunteer Crews, following our pathways and reading our descriptive plaques regarding the local wildlife, flowers and fauna. The trail is a circular walk which starts to the left of the Assault Course. At a leisurely pace, it takes about one hour to complete. The route is marked by numbered trail markers situated along the path to correspond with the map (which can be collected from the Site Office). There are a number of steep slopes in the valley areas and seats are provided along the way. In summer the trail is usually dry under foot but in wetter conditions the paths may be muddy and therefore you are advised to dress accordingly. The Site Crew and Wardens continue to manage our woodlands to the best of their ability, from time to time there will be fallen trees / branches.</p>				
<p><b>This activity is self-run by visiting group leaders. The information below is provided to assist groups' responsible leaders in the preparation of their own documented Risk Assessment.</b></p> <p><b>As the Leader in charge you are responsible for the supervision of your group, including ensuring the safety of all participants. Our risk assessment cannot take in to account the competence of the supervision nor the ability, medical condition, or attitude of the participants. This Risk Assessment does not cover activities (e.g. games, free time, camping, contingency plans), which will each require their own. You may also need to consider any specific individual needs.</b></p> <p><b>It is expected that the factors below will be considered by the groups' responsible leader when completing their own documented Risk Assessment before and during use of the activity. What other Hazards arising do you need to consider? Never be afraid to stop the activity if it is becoming unsafe! Activity Leaders are to ensure that the correct Adult / Young Person Rations are to be adhered to.</b></p>

## Lost Child Protocol

1. A lost child should stand still and shout "1,2,3 I'm over here" and repeat until found.
2. The rest of the group should stay with one adult while the other adults spread out shouting "1,2,3 Where are you" repeatedly until the missing child is located.
3. Once found, the child should then be led back to the rest of the group and adults be made aware by mobile phone.

## Emergency Procedure

1. There must be a first aider and first aid kit present amongst the Activity Users, when this activity is in progress, and there must be a functioning mobile phone carried by Instructor/ Group leader.
2. If a serious injury occurs that requires help from the emergency services, the following procedure is to be followed:
  - a) The activity is to cease.
  - b) Initial triage of the casualty is to be carried out.
  - c) 999 called with a full description of location of incident/injury given.

Acceptability of Risk Guidance	<b>High Risk: 15-25</b>	High-risk activities should cease immediately. Further effective control measures to mitigate risks must be introduced.						
	<b>Medium Risk: 8-12</b>	Medium-risks are an acceptable level based on the reduced likelihood after sufficient control measures are implemented.						
	<b>Low Risk: 1-6</b>	Low-risks are largely acceptable. Where it is reasonable to do so, efforts should be made to reduce risks further.						
Guidance. When completing a risk assessment, you should:	<ol style="list-style-type: none"> <li>1. Identify the persons at risk and the significant hazards.</li> <li>2. Calculate an initial RR for the activity.</li> <li>3. Identify risk control measures that reduce the risks to an acceptable level.</li> <li>4. Calculate a revised RR - you should consider how much safer the task will be if the control measures are followed. Here, you should consider changing both the likelihood (L) and the severity (S) ratings.</li> </ol>							
<b>Note.</b> Ideally, you should look to reduce the risks so that the task can be classified as "low-risk".								

Likelihood (L)	Definition	Points rating
<b>Inevitable</b>	If the work continues as it is, there is almost 100% certainty that an accident will happen, for examples: A broken stair or broken rung on a ladder, Bare, exposed electrical conductors, Unstable stacks of heavy boxes	5
<b>Highly likely</b>	Will happen more often than not. Additional factors could precipitate an incident but it is still likely to happen without this additional factor.	4
<b>Possible</b>	The accident may occur if additional factors precipitate it, but it is unlikely to happen without them.	3
<b>Unlikely</b>	This incident or illness might occur but the probability is low and the risk minimal.	2
<b>Remote possibility</b>	There is really no risk present. Only under freak conditions could there be any possibility of an accident or illness. All reasonable precautions have been taken - This should be the normal state of the workplace.	1

Severity (S)	Definition	Points rating
<b>Very high</b>	Causing multiple deaths and widespread destruction e.g. fire, course/building collapse.	5
<b>High</b>	Causing death, serious injury or permanent disability to an individual.	4
<b>Moderate</b>	Temporary disability causing injury (to member of the public, contractor or employees) or disease capable of keeping an employee off work for seven days or more and reportable under RIDDOR (Reporting of Injuries, Diseases and Dangerous Occurrences Regulations 1995).	3
<b>Slight</b>	Minor injury (to member of the public, contractor or employee), which would allow the individual to continue work after first aid treatment on site or at a local surgery. The duration of the stoppage or treatment is such that the normal flow of work is not seriously interrupted.	2
<b>Nil</b>	Very minor injury, bruise, graze, no risk of disease.	1
